

Stoke Fleming Dear Friends,

Firstly, a big thank you to everyone who contributed in any way to my recent fundraiser for Alzheimer's Research UK. I held a coffee morning, courtesy of the Stoke Lodge Hotel and we raised £520 which is wonderful. As many of you will know, my mother died recently and amongst other things she was suffering with vascular dementia.

I found this piece on- line and although my mother was calm and settled towards the end of her life, this, written as if by a 2-year-old child, resonated strongly with me about the frustrations and tragedy of dementia as well as being a small child.

From the diary of a 2-year-old:

Today I woke up and wanted to get dressed by myself but was told "No, we don't have time, let me do it."

This made me sad.

I wanted to feed myself for breakfast but was told, "No, you're too messy, let me do it for you."

This made me feel frustrated.

I wanted to walk to the car and get in on my own but was told, "No, we need to get going, we don't have time. Let me do it."

This made me cry.

I wanted to get out of the car on my own but was told "No, we don't have time, let me do it."

This made me want to run away.

Later I wanted to play with blocks but was told "no, not like that, like this..."

I decided I didn't want to play with blocks anymore. I wanted to play with a

doll that someone else had, so I took it. I was told "No, don't do that! You have to share."

I'm not sure what I did, but it made me sad. So, I cried. I wanted a hug but was told "No, you're fine, go play".

I'm being told it's time to pick up. I know this because someone keeps saying, "Go pick up your toys."

I am not sure what to do, I am waiting for someone to show me.

"What are you doing? Why are you just standing there? Pick up your toys, now!"

I was not allowed to dress myself or move my own body to get to where I needed to go, but now I am being asked to pick things up.

I'm not sure what to do. Is someone supposed to show me how to do this? Where do I start? Where do these things go? I am hearing a lot of words but I do not understand what is being asked of me. I am scared and do not move.

I lay down on the floor and cry.

When it was time to eat, I wanted to get my own food but was told "no, you're too little. Let me do it."

This made me feel small. I tried to eat the food in front of me but I did not put it there and someone keeps saying "Here, try this, eat this..." and putting things in my face.

I didn't want to eat anymore. This made me want to throw things and cry.

I can't get down from the table because no one will let me...because I'm too small and I can't. They keep saying I have to take a bite. This makes me cry more. I'm hungry and frustrated and sad. I'm tired and I need someone to

hold me. I do not feel safe or in control. This makes me scared. I cry even more. I am 2. No one will let me dress myself, no one will let me move my own body where it needs to go, no one will let me attend to my own needs.

However, I am expected to know how to share, "listen", or "wait a minute". I am expected to know what to say and how to act or handle my emotions. I am expected to sit still or know that if I throw something it might break.... But, I do NOT know these things.

I am not allowed to practice my skills of walking, pushing, pulling, zipping, buttoning, pouring, serving, climbing, running, throwing or doing things that I know I can do. Things that interest me and make me curious, these are the things I am NOT allowed to do.

I am 2. I am not terrible...I am frustrated. I am nervous, stressed out, overwhelmed, and confused. I need a hug'.




Children's club Thursday evenings

The sale of Bric-a-Brac and wide selection of books and trade stall goods proved very popular.



There are two outcomes we aim to achieve. It is for everyone to get together and have some FUN and to raise funds to support ongoing community activities.





Stretewise Recipe

Chicken Basque - contributed by Louise Jones

The ingredients:

6 Chicken Breasts

2 Cups of Basmati rice

4oz Chorizo - cut into slices

2oz Sun dried tomatoes

2oz Black Olives

3 x Red onions

2 x Red peppers

2 x Cloves of roughly chopped garlic

2 x Oranges

250ml White wine

1 1/2 pints of chicken stock

Oregano and Basil



Method:

Lightly fry chicken breast both sides to colour. Put rice into a baking tray. Pour chicken stock onto the rice. Lay the chicken breasts over the rice down the dish. Segment the oranges and dot around. Dot around the remaining ingredients Cook in the oven at 150-160c for one hour tightly covered with tin foil. 15 mins from the end remove the tin foil cover and add a glass of white wine.

Rhubarb Batter - contributed by Heath Robinson

First, make a batter using the recipe you normally use for Yorkshire Pudding. Leave it on one side for a while whilst you wash, dry and cut into cubes several sticks of rhubarb. Grease a roasting tin generously with butter; place the cubed rhubarb into the tin evenly; then pour over the batter.

Place just below the middle shelf of the preheated oven (190*c or 375*f) for about 45 minutes when the sides will be crisp and brown.

Serve hot with lots of Caster Sugar.



You may not be who you think you are!

This article was prompted by two things.

The NHS has been quoted in current newspaper articles on sensitive genetic tests as revealing awkward family secrets. They are trying to gene test for hereditary illnesses. It would appear that one in ten of the population as a result are mistaken as to

who their father is!

The second prompt came about when I gave myself a blood blister on my finger, this I showed to my fishmonger friend Mark Lobb and called it a 'black man's pinch'. He laughed and said you can't say that!! My reply 'Yes I can — I have.'

I told another friend I had used the above saying to which she added her children are not now allowed to sing 'Ba Ba Black Sheep'. My reply was there are lots of

black sheep in the fields near where I live!

I then told Mark some of the following story. You get the pictures – he didn't.

'Look at the colour of that baby - she's had an affair with a black GI!'

These words were what my mother had to endure when I was six months old and very suntanned. I of course did not know at the time – but this theme did not leave her and attached itself to me.



The following incident I remember as if it was yesterday.

On a trip to London aged thirteen, riding in a train; the sort which had a passage down the side and bank seats facing one another; there was a gentleman of Indian sub-continent origin sitting opposite us. He was smartly dressed and well spoken. He engaged my mother in conversation. It went like this – 'Where does she come from? Indicating me!

Her reply was 'What are you talking about?'

'Where does she come from?' He repeated again!

'She is my daughter.'

'No she isn't!'

Conversation continued in this vein for some minutes, which he ended with 'She will make me a very good wife' My mother ended it with 'She will not!' Here ended my first proposal of marriage.

At roughly this time my father's mother who died when I was 13 told me we were descended from royalty – another surprising event which I put to the back of my mind with all the rest of it; which is where it stayed until I was 45.

Aged eighteen when I went away to College; my first roommate refused to room with me on the grounds that I was black. Also at College on entering the laundry room the happy atmosphere I heard when approaching was cut as though by a knife as I opened the door. I questioned the silence; to be asked by one brave student 'Where do you come from?' My reply was Devon. Her question was repeated and my reply was the same with a few extra bits of information. They settled for my answer and the conversation resumed.

Later in 1966 after my husband Colin and I were married and we were on our honeymoon in an hotel in Cornwall an American lady asked me if I would allow her to take my photograph. I happily agreed and asked her why. The theme returned – 'I don't know how a white English girl can be so black.'

Following that incident Colin and I went to the beach at Carbis Bay. It was packed with people. He – bless him volunteered to get us an ice cream – yes, you've guessed it – he confessed later that he wondered how he would find where we were on the beach. He told me he had looked back and realised that I was the only 'black person' there. He carried the black and white photograph in his wallet all the rest of our married life until he died. Shortly after the second picture was taken I determined to find out my family history.

I plagued my living relatives for any information they had or knew of — which turned out to be quite enlightening. Then in 1990 I set about creating a questionnaire and sent it to all the listings in the local telephone directory which had my mother's maiden name, complete with covering letter and stamped self-addressed envelope. Perhaps I really was descended from the Indian sub-continent. I also scoured the record offices in London, Exeter, Truro, Plymouth and the IGI also in Plymouth. Some very interesting names were discovered, including place names. Wollaton as in near Sherford, Kingsbridge, Le Gassique as the man from Gascony in France. Perhaps my forebears had trudged halfway round the world across the land mass from India and settled in France.

I had a very large positive response from my postal endeavours and in the process I amassed a huge quantity of information on my family's history and origins, including books written and a tree on my Australian cousins of which there are many. I haven't as yet found any who were transported.

Eventually in early 2018, I was persuaded by Carol my cousin's half Danish wife to take a DNA test. I was prepared for anything as she had discovered 'half' relatives that she had no inkling about.

Contrary to all expectations my ethnicity estimate gives no indication of any other origins than Celt. However I would have been just as happy to have some Indian origins – holidays abroad looking up relatives, exciting stuff.

I took the test and joined the internet 'club', complete with creating my family tree on line. Bearing in mind the NHS belief that one in ten unions are not what they are believed to be; by taking the DNA test and going public on line you get 'matches'. Happily my close family all match!! Being of mixed race I was happy to live with – it just remained with all the other gleaned family history in the back of my mind. I feel my experience with racist discrimination allows me to openly talk about it; and I do.




One's nationality and race only belong to you. Further back in time, those you can't DNA match i.e. your ancestors - genealogical information about them has to be taken at face value.

In this research I have found some remarkable connections. My immediate family surnames are Pratt, my maiden name. The origin of the name is quite historic and means quite the opposite of its use today. A Prat was the King or Queen's court jester, in other words a comedian/entertainer for the royal household.

Sadly I haven't been able to get back further than 1800 with James and Elizabeth.

My mother's maiden name was Risdon. This is a place name. In my original search I discovered it was a land holding in one quadrant of what is now the centre of the city of Gloucester. It has armorial bearings. One of the family seats was Sandwell Manor near Totnes and there is a chapel dedicated to Dorothea Risdon in Harberton Church. I have traced this line/name sometimes corrupted in spelling by pronunciation to Rusden (Cornish does not have i's or y's) back to Moses Rusden bee master to King Charles 11. Moses wrote a book on bee keeping, called 'A Further Discovery of Bees' published in 1679. I had the heads up on this book from Beatrice Rusden - a postal response - who also kindly sent me a massive family tree containing cousins from Australia. It took me fifteen years to find a copy. 


'A Further Discovery of Bees' published in 1679. By Moses Rusden

There is yet another Risdon book also written in the 1600's. My copy was published in 1714. It is The Chorographical Description or Survey of the County of Devon. It might be of particular interest to the parishioners of Strete. Pages 62 and 63 are about us when we were part of 'Blackauton' Parish and our neighbouring Parishes of 'Stoke -Flemming' and Slapton.



A Chorographical Description Town lived one Hawly, fometime a Man o great Wealth, and worthy, whose House wa called the Hame, of whom they have the Saying rife. Blow the Wind high, or blow the Wind low, it bloweth good to Hawly's Hawe.

> TUNSTALL. Tunfall was the Inheritance of William Fires-Stephen in K. Henry P. Time. This William gave three Parts of Fee, and the Rectory of the Church of Tam. fall, unto the Abby of Torr, at the first Foundation thereof.

STOKE-FLEMMING. In this Parish, where the Lands lie low, at a Place called Blackpoole, the Lord de Cafile came ashore, and fired divers Villages, when he attempted to take Destroyand. to take Dartmouth.

STOKE. In the Church, are the Statues of a Man and Woman fairly figured in Brafs, and arched over with this French In fcription -





During that time she discovered information in The Prust Family Book. This was written in the early 1900's. Using this book and extra research she has indeed been able to trace the Prust family back many generations. I contacted her with regard to Richard Prust 1150. He is my direct ancestor and my 17th gt. grandfather. She said she was jealous as he is not her direct ancestor and she personally can't get back that far.



My 'Grandma' was right about that but she did not know that one of our Prusts whose name had corrupted to Priest was the 29th signatory to the Mayflower Compact in 1620, 400 years ago. Degory Priest my 9th gt. uncle was born in 1582 and died in 1621. He did however have children who survived him.

So now we have my maternal grandmother 'Granny'; her maiden name was Rowland. If I need to know anything about the Rowland branch I pick up the phone and ring my cousin Robert.

Her family came from South Brent and moved to Elberton, Plymouth and then to Plymstock, where they were market gardeners. They were one of the first commercial growers of tomatoes in England. Thank you Uncle Joe (Granny's brother) I love tomatoes.

I do have one hands on item handed down the female line – her parent's original marriage certificate. Marriage certificates were traditionally handed to the bride after the wedding/marriage ceremony. They are also inherited by the female members of the family – hence Great Granny Hannah Maria Horne to Granny Catherine Price Harvey Rowland to my mother Ethel Cordelia Risdon and then to me.

MINUTES OF THE ANNUAL MEETING OF STRETE PARISH COUNCIL (PC) HELD IN STRETE PARISH HALL ON THURSDAY 16 MAY 2019 AT 5.45PM

PRESENT

Cllr Kate Gill, Chairman (KG); Cllr Ralph Clark (RC); Cllr David Rothwell (DR); Cllr Ian Cumberlidge (IC); Cllr Louise Newman (LN); Cllr Peter Hales (PH); Mrs. Helen Darch – Clerk; five members of the public.

0519/1 TO RECEIVE THE SEVEN ELECTED COUNCILLORS' DECLARATION OF ACCEPTANCE OF OFFICE

Forms were duly handed out, **signed by the six Councillors present and received by the Clerk**. The acceptance of office by the seventh councillor, Graham Campbell, is dealt with at 0519/9 below.

0519/2 REGISTER OF PARISH COUNCILLOR'S INTEREST FORM

The above SHDC forms were distributed by the Clerk to the six councillors present, completed by five councillors and returned to the Clerk. The Clerk reminded councillors of the deadline of 30th May for the forms to be returned to the monitoring officer at SHDC. One form would be completed once all information was to hand and one would be completed by the absent councillor when he met with the Clerk. The Clerk would make sure the forms were returned to SHDC. Councillors were also reminded to complete and return their nil election expenses forms to SHDC.

0519/3 TO ELECT A CHAIRMAN OF THE COUNCIL FOR 2019/20

KG was eligible to stand again in accordance with Standing Orders. KG was elected Chairman for one year. All were in agreement.

0519/4 TO RECEIVE THE CHAIRMAN'S DECLARATION OF ACCEPTANCE OF OFFICE

KG duly signed her declaration of acceptance as Chairman which was received by the Clerk and took the remainder of the meeting.

PUBLIC FORUM

Five members of the public attended the meeting. Mr and Mrs. Hutton spoke on the planning application [1206/19/FUL] The Old Vicarage. They explained the existing house is structurally compromised and will need to

be demolished. The replacement dwelling will sit within the same footprint. Councillors asked questions including the use of an air source heat pump and whether this might create some noise. They were assured the pump would be located under the existing garage.

Mr Peters spoke on the planning application [1259/19/HHO] 8 Crestway, Strete TQ6 OSF. He noted he had worked closely with SHDC planners to include feedback on previous applications and the size of the extension had decreased by around 20-30% on previous plans: a substantial decrease in the development. He also requested that the present application be looked at under planning only [an appeal to the Secretary of State relating to the previous application was ongoing at the committee date].

COUNTY COUNCILLOR'S REPORT

There was no County Councillor report.

DISTRICT COUNCILLOR'S REPORT

There was no District Councillor report.

- 0519/6 MINUTES OF THE PREVIOUS MEETING HELD ON 18 APRIL 2019
 The above minutes were AGREED as a true and correct record and were signed by the Chairman.

0519/7 DECLARATIONS OF INTEREST

Parish Councillors were invited to declare any unregistered or other interest, including the nature and extent of such interests they may have in any items to be considered at this meeting. PH asked to have noted that he had previously objected to the original plans submitted for 8 Crestway [1940/18/HHO] but now would abstain.

0519/8 PLANNING AND PLANNING MATTERS

1206/19/FUL – The Old Vicarage, Hynetown, Strete TQ6 0RS

Application for demolition of existing dwelling including detached garage and the construction of replacement dwelling. Discussion took place and IC asked if the new house would be taller than the original building. He was assured there would be no increase in height.

There was unanimous support for the application.

1259/19/HHO - 8 Crestway, Strete TQ6 0SF

Householder application for extension and alterations to dwelling to form additional bedroom (Resubmission of 1940/18/HHO). Councillors were reminded to consider the planning application in front of them only [an appeal to the Secretary of State relating to the previous application was ongoing at the committee date].

A letter from No 7 Crestway on this application previously received by councillors was acknowledged [circulated to councillors on 07/05/19].

Open Forum

The meeting was closed for a member of the public to speak. Mr Peters observed the bedroom had gone back one metre but the upstairs terrace was not one metre back.

The meeting was reopened.

Councillors spoke on the plans. IC stated he couldn't support the new plans as they were nearly identical to those submitted previously. The planned works amounted to an invasion of public space. RC observed the plans represented an overdevelopment of the site. PH abstained from the discussion. DR noted the planned works were out of keeping with the rest of the neighbourhood [Crestway]. LN felt the plans represented an overdevelopment of the site. It was resolved to object as the planning application represented an overdevelopment of the site which creates a privacy issue. There were five (5) votes in favour of objection with one (1) abstention.

0519/9 CLERK'S REPORT

Conduct of business and resolution to carry over meeting

The Clerk advised councillors that it was intended to conduct the business on the agenda within the time set for this meeting of 5.45 to 7pm when the Annual Parish Meeting would then start. However, if the council meeting ran over, councillors could resolve to carry the business on after the Parish Meeting if necessary. The chairman would need to make an announcement at the start of that meeting also that the annual council meeting would carry on after that and that electors are welcome to attend.

Resolution on absent councillor

The Clerk informed councillors that they would need to resolve that

Graham Campbell's declaration of acceptance of office is to be accepted at or before the next meeting of the council.

Resolved: that Graham Campbell's declaration of acceptance of office would be accepted before the next meeting of the council on 20th June 2019. The Clerk to meet with GC to complete paperwork.

Insurance quotes – renewal due 1st June 2019

The Clerk had sent information on the insurance renewal earlier in the week. Four quotes were received as originally one failed to reply. This table at 16th May updates the email and schedule of comparative quotes sent 15th May.

After a discussion on the merits of a blanket quote and quotes based on the existing [ongoing] asset register councillors opted to retain blanket cover for assets. In addition, cover includes money, employer liability, public liability, fidelity guarantee, libel and slander, officials' indemnity and legal expenses cover. LN noted the risks of excluding assets which then needed repair for instance in another authority damage to the milestones proved costly when these were excluded from cover. Resolved: that the Clerk would contact BHIB and ask if they could match Norris and Fisher's quote. However, to go ahead with the cover offered by BHIB in the sum of £365.87 and arrange payment of the premium by the due date.

The Clerk subsequently contacted BHIB and obtained a revised quote of £336.83 on the same terms which was then acted on.

The report was received.

0519/10 CHAIR'S REPORT

Slapton Line. The position is still the same as last month. The topic is where to place the memorial. This in itself is a difficult subject- each person asked has a differing viewpoint. Torcross have nowhere to put it — they have a car park. Slapton proposes to put it on the public footpath on Sands Road — they don't have a carpark- and the traffic congestion in Slapton is appalling. Strete could host it at Strete Gate — there are two possible positions: the strawberry field and also the level area just behind the wall which has pedestrian access through the existing doorway. We have a proper carpark.

Strete Gate. We have issues again! It was brought to my attention through email that unsuitable behaviour has recommenced toward Pilchard Cove. Sadly, our police force is very stretched and more so this year. So, it is unlikely we will have a willing member of the Force doing recces in mufti.

Planning. There are two applications this month.

WIFI. This has been installed but we are yet to sort the precise final position. But this is in hand and was discussed last night at the Parish Hall Committee meeting.

Playpark. This is still being enjoyed.

Trees. I'm sure that Ian will have already picked this up. It was reported to me yesterday that there appears to be an ash tree near Skerries which is suffering from dieback.

Bottle bank. This last month we have had issues with fly tipping of bottles. On the 24th April I had to ring SHDC to do a lift. This left a massive quantity of bottles to be put into the new bank. I had some very welcome help from the caretaker lady from the static site who brought bottles to be put in! Between us we cleared up the mess. Thank you.

VAS. Ralph has taken the baton and persuaded Westcotec to service the poorly machine. Thankyou Ralph. **The report was received.**

0519/12(a)FINANCE

The Clerk supplied the meeting with a list of cheques for payment. A late cheque 1652 was added to the list on the agenda.

takes action it as it is a Highways issue identified, the Council does not have any legislative power to take action with the Councillor on the issues advised nor put into place sanctions of any form.

It's for the Police or the Higher Authority if they are contacted by the complainant, it would not be for the Parish Council to forward such correspondence to either as it is unable to formally confirm their identification. So, as the correspondence is anonymous Council is unable to correspond with the complainant and therefore unable to reply to the complainant so no action can be taken.




HMS Friendship

HMS Friendship was a 4-gun singlemasted cutter of the Royal Navy, purchased in 1763 for coastal patrol duties in the immediate aftermath of the Seven Years' War with France. She was stationed for eight years' service in Start Bay. HMS Friendship was one of thirty cutters ordered to be purchased by the Royal Navy in a threemonth period from December 1762 to February 1763 for coastal duties off English ports. The function of these purchased cutters included convoy and patrol, the carrying of messages between Navy vessels in port and assisting the press gang in the interception of merchant craft.

Admiralty Orders for her purchase were issued on 16 February 1763 with the transaction completed at a price of £316. On 8 April 1763 the newly purchased cutter sailed to Woolwich Dockyard for fitting out as a Navy craft. Two months late on 17 June, at a total




cost of £501 she was rebuilt for Navy service, she was armed with four three-pounder cannons and six pounder swivel guns, with a complement of 24 crew. In April 1763 and the vessel entered the Navy as a patrol cutter in Start Bay. Her first commander was Lieutenant Patrick Strachan. In 1766 command passed to Lieutenant Rowland Pigot and then in 1768 to Lieutenant John Glover. HMS Friendship remained at the same station in Start Bay throughout these changes of command.

In September 1769 she captured a smuggler's vessel carrying two hundred gallons of brandy and a quantity of tea.

The Royal Navy impressed many merchant sailors, as well as some sailors from other nations. People liable to impressment were "eligible men of seafaring habits between the ages of 18 and 55 years". Non-seamen were impressed as well (Landsmen) Outbound merchant ships, officers and apprentices were exempt from impressment. When war broke out the Navy would deploy frigates and cutters off the coast to intercept inbound merchantman. Reportedly some merchant captains redirected their ships to Irish ports to offload favoured crewmen, before making final land-fall in England. In times of an extreme shortage of men, the Navy would "embargo" the coast for a short time; merchantmen had to supply a portion of their crew in exchange for permission to sail.

Many merchant ships had hiding places constructed where their best crew could hide when approached by a Naval vessel. In addition to impressment, Britain also used the Quota System (or *The Quod*) from 1795 to 1815, whereby each county was required to supply a certain number of volunteers, based on its population and the number of its seaports.

MINUTES OF A MEETING OF STRETE PARISH COUNCIL (PC)HELD IN STRETE PARISH HALL ON THURSDAY 20 JUNE 2019 AT 7.00 PM

PRESENT

PUBLIC FORUM

No members of the public attended the meeting.

COUNTY COUNCILLOR'S REPORT

JB noted there was not much to report. Devon County Council [DCC] had had their annual meeting and JB was back on Children's Scrutiny. The main areas DCC will have to deal with are adult social care, children's education, and special educational needs. There are clear cost pressures associated with all of these services but all are statutory and must be delivered.

DCC has started work on the back roads [previous minutes refer]. So far, no complaints have been received. The road to Slapton [5-mile Lane] needs work but there is no money.

The two recent applications: 8 Crestway [1940/18/ HHO and 1259/19/ HHO] and Blindwells [3400/18/FUL and 1561/19/FUL] were briefly referred to. Both had planning appeals [with The Planning Inspectorate] ongoing in relation to the original application. Also, both had revised applications due to be dealt with by SHDC. JB noted the revised planning application for Blindwells dealt with one house on part of the plot. At the time of meeting neither appeal had been decided.

Subsequent to the meeting the Planning inspector ruled on 8 Crestway in favour of the applicant.

DISTRICT COUNCILLOR'S REPORT

There was no District Councilor report.

O619/1 APOLOGIES – Cllr Richard Foss, District Councillor, Allington & Strete Ward (RF); Cllr Ralph Clark (RC); Cllr Ian Cumberlidge (IC); Cllr David Rothwell (DC)

0619/2 MINUTES OF THE PREVIOUS MEETING HELD ON 16 MAY 2019

The above minutes were AGREED as a true and correct record and were signed by the Chairman.

0619/3 DECLARATIONS OF INTEREST

Parish Councillors were invited to declare any unregistered or other interest, including the nature and extent of such interests they may have in any items to be considered at this meeting. PH noted that the planning application [1561/19/FUL] concerned a property across the road from his house and so he would abstain [recuse himself].

0619/4 CLERK'S REPORT

Fixed asset register. The Clerk circulated an updated fixed asset which now includes all assets she has been able to identify from invoices and minutes. The starting point is the register drawn up in 2010 for the audit in that year and this has been added to with acquisitions since 2010. Assets are valued at purchase cost except the war memorial which has an insurance value of £30,000 based on the BHIB cover. Some assets are unvalued eg the milestones. The register has a total value of £88,031 including the war memorial at June 2019. The assets will be included in next year's accounts. KG asked about the expiry of the Asset of Community Value application on the Pub. This expires in June 2020. Resolved: The Clerk would look at renewing the Asset of Community value application on the Pub. Councillors were asked to review the register and update it with any additions. The Clerk was requested to circulate a report done in 2011 by Malcolm Hollis on the milestones to all.

Audit. The inspection of accounts commenced on Monday 17th June and will finish on Friday 26th July.

Financial regulations. Have been updated and in draft based on the latest National Association of Local Councils/ Devon Association of Local Councils template. Councillors were asked to review a copy which will be circulated with a view to adopt at the next meeting. The regulations were last discussed in October 2015. **Resolved: The Clerk will send round a draft for review.**

Standing orders – these were last updated in October 2015 but a draft was produced in 2018. **Resolved: The Standing Orders will be reviewed and reported on at a later meeting.**

Code of conduct – this was last updated in June 2012. Resolved: The Clerk will check if a later model version of the Code of Conduct is now available and produce an updated version for approval.

The report was received.

JB then left the meeting.

0619/5 CHAIR'S REPORT

20.06.19

Michael Toll – our Lord of the Manor died last month on 4th May, his funeral service was held on 21st May in St Michael's followed by his wake here in The Parish Hall. His elder son Bryan Toll now holds the title.

<u>Slapton Line</u> – at the SLP Meeting held in Slapton Village Hall on 5th June the positioning of the War Memorial was top of the Agenda. My comments in last month's report proved correct.

The site Slapton wished to use proved to be totally unsuitable; consequently we are looking to place it at Strete Gate.

The ideal place would be in the picnic area up the steps behind the wall. Access for work/installation is already there.

This would enable it to be seen from the sea where the practice landings took place. We have a car park which could be potentially enlarged – I have already tentatively mentioned it to Bryan and to his agent Charles Dixon. Mr Toll owns the field adjacent to the existing car park.

<u>Strete Gate</u> – Lisa Edmonds DCC has done it for us!! The tarmac was laid on 12th May and she rang me with great glee to tell me that the white lines had been done on 10th June. Since then parking has been much tidier.

SHDC has managed to put some posts on the beach side which will now stop 4-wheel drive vehicles parking on the SSSI.

Kim Ryder of Lime Coffee Kiosk has also managed to get the shutting of

the gate done; complete with a padlock which works - also to prevent vehicles – saunas - motorhomes and the like from parking there. Very well done all round.

The result is much tidier parking even if the vehicles are very large – however – BBQ's are still being lit between the vehicles; this is extremely dangerous. In certain conditions lives could be put seriously at risk. I know! My home was put at risk in such circumstances when my family were evacuated, and eight fire engines arrived.

<u>Planning</u> – Blindwells is now at appeal, but they have put in a further application for the site. 1561/19/FUL This is on the agenda tonight.

<u>Litter on the shingle at Strete Gate</u> – it was reported to me that a school prom party had been held on the beach Strete end of the Line. A video was taken of the mess and the name of one of the perpetrators was found on a discarded item.

Play Park – needs new information notices.

The Chair's report was received.

0619/6 PLANNING & PLANNING MATTERS

[1561/19/FUL] Erection of detached dwelling and garage and formation of vehicular access. Blindwells, Hynetown Road, Strete TQ6 ORS. Comments had already been submitted by email from RC, GC and PH. A discussion then took place. PH abstained from the discussion. GC commented this was a self-build and okay because it was not as close to its neighbour [on the left facing onto Hynetown Road] as the previous application and is a buildable plot. However, he was concerned if future applications applied for development of the site 'one-by-one'. LN thought it was close to the boundary on the left but not too crowded and certainly less so than three on one site. She also wondered if there might be privacy issues. IC was not present so KG conveyed his concerns over the Tree Preservation Order on the site which is temporary and will need to be reapplied for. [TPO no 983 served 17th April 2019]. IC had also suggested the people who wanted to build objected to the TPO and so it was important to keep it in place. Councillors wondered if the site plan represented the trees on site accurately or were for illustration only.

KG commented the post box on Hynetown Road would need to be relocated and that she wanted the rural bank that runs along the Hynetown Road side of Blindwells [a Devon hedge bank] retained.

Resolved that the council would NOT object subject to:

The trees being maintained

The post-box to be relocated on the Devon hedge bank

The bank to remain a Devon hedge bank.

0619/7 NEIGHBOURHOOD PLAN

As RC was absent the Clerk read out his submission to the meeting. NP Report for PC – June 2019

On the 20th May SHDC made contact and advised Mrs Deborah McCann (the examiner) had decided to request an exploratory public meeting for Strete Neighbourhood Plan.

The objective of the meeting was to specifically explore in detail, with a representative of the Strete Neighbourhood Plan, South Hams District Council and a representative of the owner of Cox's Farm Field, issues arising from the plan in connection with the delivery of housing across the plan period.

A public notice was displayed in the village notice boards and on Strete website informing the exploratory meeting would take place at 2pm on Tuesday 11th of June 2019 at Strete Parish Hall.

The meeting opened with DM explaining the examination of the plan is to ensure it meets the basic conditions as set out in paragraph 8(2) of Schedule 4B to the Town and Country Planning Act 1990 (introduced by Schedule 10 of the Localism Act 2011).

The exploratory meeting process is new and has been added to assist examiners in their role.

Mr Duncan Smith of SHDC was asked to comment on where Strete NP sat within the recently adopted Plymouth and South West Devon Joint Local Plan. DS confirmed there was no minimum target in the JLP for housing in the village although there was a recognised need for some housing. SHDC supported the decision made by the community of Strete to proceed with a NP that included a vision for housing.

R. Clark representing Strete NP was asked to comment on how Cox's Farm Field was determined to be the site for housing development.

RC explained that with a tight settlement boundary, as recommended by SHDC and Natural England, a site assessment determined that Cox's Farm Field is the only and most sustainable site to accommodate a viable housing development to meet the needs and aspirations of the community.

Consultation with regulatory organisations to ensure all the necessary environmental and historical aspects of the site have been considered and included, including a Strategic Environmental Assessment Report that supports the plan.

Extensive discussions by Steering Group members to confirm and agree CFF was the preferred site for housing development was concluded before consultation with the community took place.

DM asked if consultation with the landowner had taken place.

RC confirmed Mr Charles Dixon of Strete Estate responded to a public Call for Sites advert in the local press offering two sites for development consideration in December 2016.

Initial correspondence culminated in a meeting with CD and members of the Steering Group for Strete NP in August 2017. CD expressed his concern at the way the group were delivering the NP without consultation with the landowner. In particular: -

- The size of the housing development
- Conditions to accompany a housing development Car Park, Footpath & Open Space.
- Principal Residency Requirement
 These points were confirmed by CD in his comments to DM at the meeting.

Correspondence with CD continued through to October 2017 when CD informed the group that unless the conditions were removed from the NP the site would be withdrawn for development.

RC informed CD of the SG's unanimous decision to retain the Principal Residency Policy.

This resulted in no further dialogue or correspondence with Strete Estate. Following recommended changes to the plan that were subject to a Regulation 14 six-week Re-Consultation period, only response comments were received from CD.

DM concluded that the current impasse could only be resolved if the parties involved agreed to enter into discussions to address the concerns of each party.

DS suggested an initial meeting be arranged to establish if suggested changes

to policy wording could be proposed for consideration and possible acceptance.

CD explained his client had recently died and that the estate was in probate which could take several months to conclude.

DM informed the meeting of the intention to suspend the examination of Strete NP for six months to provide an opportunity for all parties to meet and discuss the objection to the allocation of Cox's Farm Field for residential development in Strete NP.

At the end of the six month period DM will consult on the progress made and consider whether to extend the period further or recommence the examination of the plan as submitted.

DM closed the meeting at 4pm.

The NP report was received.

0619/8 UPDATE ON THE SLAPTON LINE, PLACING OF THE WAR MEMORIAL & PROVISION OF EXTRA PARKING ALONG THE SLAPTON LINE

KG reported back from the last Slapton Line Partnership [SLP] meeting that in time the sea would be allowed to take the road away at the memorial. If this happens there will be dead ends at Strete Gate and Torcross. The war memorial will then need to be moved to a place of safety. It is preferred that this new home is in the area the US army did their practicing for D-day: that is somewhere along the beach. This is likely to be at Strete Gate. The SLP will have to negotiate placement and access with the Field Studies Centre as the land on the picnic area at Strete Gate now belongs to the Ley Centre.

GC asked who had decided that the road would not be rebuilt in the future. He expressed concern about the effect on the local economy. KG replied that Natural England as the guardian of the SSSI wants the land to return to salt marsh. LN commented Plymouth University had studied the environment and advised the beach shingle would overcome the road in time. GC noted the alternative roads are not good and he wondered if people and business would start to move out of the area if the road became unusable.

The report was received.

0619/9 ACCESS TO THE BEACH FROM THE PUBLIC TOILETS

KG reported that SHDC was responsible for blocking access from the [removed] steps and carpark to the beach. IC is in negotiation with SHDC [Luke Rees] to get the steps reinstated. GC noted there is a safety issue now as people have to walk down the busy road at the moment to get to

the beach.

The report was received.

0619/10 VILLAGE PUMP

IC has removed the ivy from the pump. The walls could be reinforced with acrow props.

The report was received.

0619/11 UPDATE ON CONTRACTS

Hedges. LN had received a complaint about the bank hanging out on Vicarage Lane. Resolved: LN will get John Gilbert to come and do it once the nesting season is finished. This will be subject to quote.

Greenspace is now billing on a monthly basis in accordance with the schedule sent to them in the contract in March. Resolved: The Clerk will send GC a copy of the contract from 1st April 2019 agreed with Greenspace. GC will check what is being done and get in touch with the contractor; regular grass cutting for the VAS verge to be added to the contract.

WIFI – this will be discussed further at the Parish Hall Committee on 17th July.

Playpark. A report was received from the localities officer that two chain rungs are broken on one of the swings. This will be checked out.

0619/12 COUNCILLORS' REPORTS

KG (Chair) Playpark. Reported on in 0619/5.

LN Transport and Roads. This was dealt with in 0619/11.

DR Health and Safety. The Clerk reported on the telephone box. A planning application had been submitted by the council [1093/19/LBC] and SHDC planners had requested further information which had been sent on. The decision is awaited.

Subsequent to this meeting the planners replied to agree the application.

IC Rights of Way, tree warden and Strete Gate. Rights of Way were okay. Tree warden. The TPO [see 0619/6 above] had been discussed. IC wanted the TPO to be made permanent. Resolved: The Clerk would confirm if the TPO was permanent or not and report back.

Strete Gate: had already been discussed.

RC Planning and Neighbourhood Plan. Nothing more to add.

PH The VAS sign and local transport liaison. The VAS is now operational and had been repaired under warranty. The batteries need to be charged fortnightly. GC noted a conversion kit could be applied and PH would look at this. PH had spoken with Tony Crawford about transport liaison with the bus company through Dartmouth Town Council but this forum is now disbanded. Resolved: PH will continue enquiries.

GC Village Green. GC wondered if there would be any interest in approaching Daisy's Dog Food to install emergency dog bags at the Green akin to those which that Daisy's Dog Food had placed in Strete Gate.





Stretewise Recipe

Green Tomato Chutney - contributed by Bryan Seymour (from the archive)

An ideal recipe for using up those green tomatoes in the greenhouse and seasonal cooking apples.

The ingredients:

1 kg (2^{1/2}lb) green tomatoes
1 kg (2^{1/2}lb) cooking apples
900g (2lb) onions
6 large cloves of garlic, crushed
450g (1lb) raisins
625g (6oz) soft brown sugar (or demerara)
25g (1oz) pickling spice
Half a tablespoon of cayenne pepper
2 level dessertspoons of ground ginger
Half a tablespoon of salt
1.75 ltr (3 pints) malt vinegar

A small preserving pan 8 450g (1lb) preserving jars String and some gauze



Method:

Wash the tomatoes and peel the onions and cut them into quarters. Peel and core the apples (keep in water to prevent browning).

Mince the tomatoes and place in the pan, next the onions, then the raisins followed by the apples. Add garlic, cayenne, salt, ginger and sugar blending everything thoroughly. Next tie the pickling spice in a small piece of double gauze and hang in the pan. Pour in the vinegar and bring to simmering point, removing any scum from the surface. Let it simmer very gently, without covering, for 3^{1/2} hours. Stir now and then to prevent sticking. It is ready when the vinegar has been almost absorbed and the chutney has thickened to a nice soft consistency and the spoon leave a trail. Be careful not to overcook - it thickens up quite a bit as it cools.

Pour the hot chutney into hot jars, filling them as full as possible. Cover with waxed sealing discs and seal with a tight lid at once. Label jars when the chutney is cold.
